F3 Paint & Quarter Horses will be referred to as Breeder: This service is engaged subject to the following:

1. A **Booking Fee of \$100** from the above breeding fee is payable with this contract, and the balance of \$ \_\_\_\_\_ plus all unpaid expenses will be payable upon receipt of invoice or when mare leaves the farm whichever is first.
2. The breeding season for 2012 is from February 1 to June 15.
3. A **photocopy** of the registration papers shall be sent to the Breeder with this contract.
4. Current Coggins test (6 months) & Health papers shall accompany the mare(s).
5. Mare Owner agrees each mare offered for breeding shall be in sound breeding condition and free from an infection or disease. Mare must be halter broke.
6. The Breeder agrees to diligently try to settle the above named mare and shall have sole discretion of determining the best method of breeding such mare. If the mare does not settle, the Breeder shall be held harmless.
7. **Live Foal Guarantee:** Live foal means the foal shall stand and nurse and lives 24 hours.
8. A breeder's certificate will be issued to Mare Owner after all expenses have been paid in full and upon notification of birth of foal.
9. **Mare Care, Veterinarian expenses, or any other expenses of mare will be paid monthly by the mare owner to Breeder.**
10. This contract shall become null and void and booking fee will be refunded if stallion dies or becomes unfit for service.
11. It is understood that the breeding farm, its owners, employees, and guests shall not be liable for any injury, escape, disability, or death of any horse on its premises.

This contract is not valid unless completed in full. When Mare Owner signs and returns the contract with booking fee the Breeder will sign and return a copy to the Mare Owner. Mail contact to the above address.
